## Additional information:

- All Service Charges are quoted exclusive of GST.**  
GST is charged at a rate of 10% where applicable. Where the services are being contracted and paid for by a third-party GST is applied to all services. Clients paying Seniors Community Care directly are exempt from GST for Personal Care, Respite Care, Escorted Shopping & Appointments, Overnight Care and Nursing Services.
- Service charges are in 30-minute increments following the minimum service engagement.
- \* Services can be provided consecutively with other service types (if with same carer) to adhere to minimum service engagement.
- Weekdays After Hours Services** are charged for the whole of such service that finishes after 6.00pm or commences before 7.00am Monday to Friday.
- # Overnight Care** is an inactive night duty shift, including 4 active hours (either at the start, or at the end of the shift, or split between both) and requires separate sleeping facilities to be provided for the staff member. If more active

hours of care are provided than specified, active overnight support is to be charged at the hourly care rates.

**6. \*\* Short Nursing Care** services are limited to medication administration excluding intravenous.

**7. ## Nursing Assessments** may include an additional up to 30 minutes administration post-home visit. Assessments include but not limited to, Continence (including SWEP applications), Diabetes Management, General Nursing, Stomal Therapy, Wound Management and Dementia & Cognition.

**8.** All services provided on gazetted Victorian **Public Holidays** are subject to double time rates. In addition, public holiday rates also apply to Christmas Day and New Year's Day when they fall on a weekend. If regular services fall on a public holiday they will go ahead as scheduled unless Seniors Community Care is notified to cancel or reschedule.

**9. Cancellations:** Seniors Community Care has responsibility to its carers to provide appropriate notice and therefore require 24-hour notice of cancellation. Service cancelled with less notice period than 24 hours will be charged the full-service fee.
